Rush—Don't Flush...

.....to one of three collection sites on Saturday, September 25, from 9 a.m. to 2 p.m., to dispose of your unwanted pharmaceuticals: Greensburg City Hall, Lincoln Road Shopping Center in Latrobe, or the Murrysville Community Library. Its FREE!!

National Take Back Initiative

"On Saturday, September 25, the US Department of Justice Drug Enforcement Administration is coordinating a collaborative effort with state and local law enforcement agencies focused on removing potentially dangerous controlled substances from our nation's medicine cabinets. This national take-back day will provide a unified opportunity for the public to surrender expired, unwanted, or unused pharmaceutical controlled substances and other medications to law enforcement officers for destruction. This one-day effort will bring national focus to the issue of pharmaceutical controlled substance abuse. The program also provides an opportunity for law enforcement, prevention, treatment, and the business community to collaborate and establish a safe collection site for all Americans, regardless of where they reside."

Westmoreland Cleanways began planning for a collection for unwanted pharmaceuticals in early 2009. Local partners were identified, and all agreed that the presence of pharmaceutical chemicals entering our nation's drinking water supply has the potential of becoming a national health crisis, not to mention an environmental disaster.

Organizations such as the US Environmental Protection Agency, the National Association of Counties, the Society of Environmental Toxicology and Chemistry, the PA Pharmacists Association, among others, have publicly stated that unwanted medicine disposal poses great concern across a broad spectrum of issues, including human and environmental health, water quality, solid waste management, and the health care industry.

Currently, there are about 3,000 prescription pharmaceuticals in use in the U.S. and thousands more over-the-counter drugs. "Between cosmetics, pharmaceuticals and other sources," says John Spatz, commissioner of Chicago's department of water management, "there are 80,000 potential combinations of chemicals." Most municipal water treatment plants are not equipped to remove them from our water supply. Wastewater

from homes gets treated at sewage plants but still can't remove every trace of drugs. Sewage pipes break, septic tanks overflow, and "straight-piping", which sends untreated sewage directly into surface water, is still practiced. Sludge from wastewater treatment plants is often applied to agricultural land as fertilizer. Combine all of these sources, and it's no surprise that a wide range of pharmaceutical chemicals have been found in rivers and streams nationwide.

The long-term impact of exposure to mixed pharmaceuticals is not yet known. Various studies found deformed amphibians, and reproductive disorders in fish. What is known is that, by their nature, these substances are specifically designed to be reactive with human tissue. Otherwise, they'd be useless.

Aside from the human health and environmental threat, improper disposal of unwanted medications can pose a threat to children and pets. Medications placed in the trash without taking the precaution of securing the container or making the contents unpalatable may result in unintentional poisoning. Medications disposed with their original labels still intact can result in identity theft and drug theft, of special importance to the elderly, the largest consumers of prescribed medications.

Westmoreland Cleanways is especially pleased to partner with the US Department of Justice Drug Enforcement Administration on this extremely important issue.

### **So You Can't Make the Collection ... What Should You Do?**

If you will be unable to attend the September 25 collection, or for future reference, please use the following guidelines as the safest preferred way to dispose of unwanted medications, solid or liquid:

1. Destroy the medication to make it unpalatable: add liquid to partially dissolve and mix with cat litter (used is good!), sand or dirt.
2. Scratch out patient information on any prescription bottles or boxes.
3. Put in a plastic bag and seal well with tape.
4. Place in trash as close to garbage pickup day as possible.

**DO NOT FLUSH!!!**

### ~~~~ On The Day Of The Collection ~~~~

The safest way to transport the drugs is in their original container. **Do not mix pills.**

**What Will Be Accepted:** Pills and solids only!!!

 Veterinary meds

**What Will NOT Be Accepted:**

**Be Prepared To:**

Remove pills/capsules from their container and place them directly into a disposal box. Take the original container home with you.

This collection is completely anonymous and secure. No one will ask you what you have or whose it is. Armed law enforcement officers will be at the site to oversee the material being dropped into a SEALED disposal box. You will take your containers back home with you so there is no chance of identify theft.

Volunteers will be on hand to provide assistance if needed.



## Education News

### Trash to Treasure—Classroom Compost Project

"Trash to Treasure" is a new program that will be introduced to county schools this school year. The goal of the "Trash to Treasure" composting education program is to provide students with an understanding of composting and how it positively impacts our community. Currently, no schools in Westmoreland County have a comprehensive composting program. By providing students with an understanding of waste production and the management of that waste, this program can lead students to interdisciplinary study through experiments involving mathematics, science and language arts. School composting provides an opportunity for real-world problem solving with cooperative learning student groups, and can motivate those students who feel intimidated by traditional science experiences. Students gain an awareness of an individual's role in the world today as they learn how waste is produced and how it can be reduced, along with non-source point pollution.

All county middle or high schools are eligible to participate in the Trash to Treasure program. Participating schools will receive a compost bin, manuals, and technical assistance needed to conduct the program, at absolutely no cost.

### Landfill Tour



What really goes on in a landfill? Is it the smelly mess we all imagine? Not hardly! Students and staff of the K.A.R.A.T. School in Greensburg recently learned the truth about where our garbage goes during a recent tour of the Waste Management Valley Landfill in Penn Township, hosted by Jerry Sabatini, District Landfill Manager, and Carl Ciccarella, WM Environmental Protection Manager.

Visitors were able to see the life cycle of the landfill, from the trash truck crossing the scale, to the methane and leachate capture systems, and even the construction of a new cell, the hole where daily trash is dumped.

While waste reduction and recycling will always be the preferred ways to manage waste, it is important to know that some stuff just has to be landfilled. It is also important to feel confident that today's modern sanitary landfills employ the latest technology and resources to ensure that no harmful residue escapes into the environment.

Westmoreland Cleanways and Valley Landfill are sponsoring another landfill tour for the general public on Saturday, October 16, in conjunction with a Backyard Composting Workshop. (Valley also has the largest commercial composting site open to the public in the county.) Cost is \$10 and reservations are required. Please join us for this fascinating excursion.

GreenSylvania

Westmoreland Cleanways proudly introduces GreenSylvania to local schools this coming school year. Sponsored by PROP, the Professional Recyclers of PA, the "GreenSylvania" competition brings enthusiasm and increased recycling to Pennsylvania's public and private K-12 schools. Students, faculty, staff and school administrators become engaged in designing a program to enhance recycling participation and recovery over a one-month period. Recycling is measured over time and compared to baseline results or recycling in other competing schools. To level the playing field among participating schools, the weight of recycled materials collected during the competition is calculated on a per capita basis based on the total school population.

The goal of GreenSylvania is to increase diversion of school recyclables from disposal during and after the competition. GreenSylvania offers a number of educational skills and concepts that can be interwoven with the competition such as science, math, writing and environmental stewardship. Additionally, a school's image is enhanced as a contributor to the community's recycling effort.

Online registration at www.greensylvania.org begins September 1 and ends September 30 with the actual competition being held from October 4 through 30, 2010. The traveling trophy will be awarded to the winning school on or about November 15, America Recycles Day!

Yough River Cleanup Planned



A pretty exciting cleanup project is planned for this coming fall, one that I think everyone will enjoy while we get some serious cleanup work done. We received a call in mid-July from a man and his son who had just taken a weekend canoe trip down the Youghiogheny River near West Newton. The son, Michael, was dismayed at the number of old tires choking the river and that lay scattered along the banks, and asked his dad, David, to see what could be done. Now Westmoreland Cleanways has long been aware of the tires; they were one of the first problems I encountered back in 1998. No one was ever quite sure what to do with them, clean them up or let them lie. The other problem was, unfortunately, trashy people continued to dump more tires into the river.

Well, thanks to Michael, we renewed our investigation, got a definitive answer from the PA Fish and Boat Commission on what to clean up, and approached Cuffy Lash at the Youghiogheny Canoe Outfitters about helping with a cleanup. You'da thought Cuffy was just waiting for me to walk in the door! He told me that YCO had sponsored several tire cleanups along the Yough in the past, and would certainly do so again if we put a cleanup together. Meanwhile, Michael approached his Outdoor Club Advisor at Belle Vernon High School, Mr. Jenkins, and the makings of a cleanup are well under way. Here's the scoop:

The cleanup will take place probably on a Sunday in October. The Belle Vernon Outdoor Club will pick a date for the cleanup once classes resume in September. All volunteers will receive a free canoe from Yough Canoe Outfitters, who will transport everyone upstream to the launch at Cedar Creek Park. Volunteers will pick up tires out of the river and off the riverbanks as they canoe down toward West Newton. West Newton Borough will arrange for a rolloff to put the tires in and for disposal. The sojourn will end at the Youghiogheny Canoe Outfitters where we'll meet for lunch and laughs.

What we still need: More volunteers—everyone is welcome! Skidoos—Cuffy told me that a skidoo is really helpful to help transport tires from the canoes to the rolloff. Each canoer can continue to get tires as they float down the river. Lunch—Anyone willing to provide (or donate funds for) lunch would be greatly appreciated. Our volunteers will be working up quite an appetite.

Check our website and Facebook later in September for the date of the Yough River Cleanup; call to volunteer; and call if you're willing to use your Skidoo or provide refreshments. It should be fun!

## Westmoreland Gives
